Talk about Right to Work and what has happened in other states that are now Right to Work states as far as benefits, salaries, etc. Address what unions can do to keep their membership numbers and not have employees quit on their union.

Your conclusion would be an argument of what you would tell someone who is thinking about opting out of the union and how you will convince them to remain full-fledged members.
